**KNOW ALL MEN BY THESE PRESENTS,**

THAT IN CONSIDERATION OF One Hundred Fifty-Five Thousand Four Hundred and No/100 Dollars (\$155,400.00) paid to the undersigned Grantor, in hand paid by the Grantee herein, the receipt of which is hereby acknowledged, **GNC, LLC**, an Alabama limited liability company (herein referred to as Grantor), does grant, bargain, sell and convey unto **HIGH CREST CONSTRUCTION, L.L.C.**, an Alabama limited liability company (herein referred to as Grantee), the following described real estate (herein referred to as the Property), situated in the State of Alabama, County of Shelby, to-wit:

For purposes of this paragraph, the term Grantor shall mean and refer to (i) the members, agents and employees of Grantor; and (ii) any successors and assigns of Grantor. This covenant and agreement shall run with the land conveyed hereby as against Grantee, and all persons, firms, trusts, partnerships, limited partnerships, corporations, or other entities holding under or through the Grantee.


