

MORTGAGE MODIFICATION AGREEMENT



THIS MORTGAGE MODIFICATION AGREEMENT is made and entered into on this the 19TH day of AUGUST, 2005 by and between KEVIN GRAY AND SPOUSE, MISTY GRAY (hereinafter referred to as the "Mortgagors") and CENTRAL STATE BANK, (hereinafter called the "Mortgagee").
