Article I         The name of the corporation:

Article II        The period of duration is perpetual.

Article III       The corporation has been organized for the following purpose(s):

The general purposes for which this corporation is formed are to operate exclusively for such religious, charitable, and educational purposes as the corporation elects. The specific and primary purposes for which this corporation is formed are to operate for the advancement of religious, charitable, and educational goals as dictated by the Bible and by Christian faith.

This corporation shall not have a substantial part of its activities carry on propaganda or otherwise attempt to influence legislation, nor shall it participate or intervene by publication or distribution of any statement or otherwise in any political campaign on behalf of any candidate for public office. This corporation is to operate exclusively for such Christian, charitable, and other educational purposes as allowed for an exempt organization under Section 501 (c) (3) of the Internal Revenue Code or corresponding provisions of any subsequent Federal Tax laws.

Article IV        The corporation shall have a membership that includes the official board. The authorized number and qualifications of members of the corporation, the manner of admissions, the different classes of membership, if any, the


