Commence at the Southwest corner of the NE 1/4 of the NW 1/4 of Section 22, Township 19 South, Range 2 East and run thence North 00 deg. 50 min. 01 sec. East along the West line of said quarter-quarter section a distance of 1,302.96 feet to a point; thence run North 89 deg. 42 min. 43 sec. East a distance of 664.39 feet to a found rebar corner on the South margin of Shelby County Highway No. 62 and the point of beginning of the property being described; thence continue last described course a distance of 329.96 feet to a found open top pipe corner; thence run South 01 deg. 09 min. 17 sec.
