ARTICLES OF ORGANIZATION OF  
**KELLY MCDONALD HAIR DESIGN LLC**

TO THE HONORABLE, JUDGE OF PROBATE,  
OF Shelby COUNTY, ALABAMA:

The undersigned, acting as organizer of **KELLY MCDONALD HAIR DESIGN LLC** under the Alabama Limited Liability Company Act, adopt the following Articles of Organization:

1. NAME: The name of the limited liability company is: **KELLY MCDONALD HAIR DESIGN LLC**.
2. DURATION: The Company's period of duration is shall commence on the date of filing of these articles with the probate judge of Shelby County, ALABAMA, and shall continue for no more than THIRTY (30) YEARS from said date, unless dissolved sooner by its Members, in accordance with the provisions of its operating agreement, or as provided by statute.
3. PURPOSE: The purpose for which this limited liability company is organized is to engage in any lawful act authorized pursuant to Alabama Code Section 10-12-4 as of the date of the execution of these Articles of Organization.
4. PRINCIPAL PLACE OF BUSINESS: The address of its principal place of business is:

5. REGISTERED AGENT & OFFICE: The name of its registered agent is: **KELLY MCDONALD**, and the address of the registered office is: 2615 Suite C Pelham Pkwy.
6. MEMBERS: The Members and their mailing addresses are as follows: **KELLY MCDONALD** at 2615 Suite C Pelham Pkwy Pelham AL 35124

ADDITIONAL MEMBERS: Additional Members will be admitted only upon majority consent, in writing, of the Members upon such terms as are agreed to by a majority of its members.

8. ADDITIONAL CAPITAL CONTRIBUTION OF MEMBERS: Additional contributions will be made at such times and in such amounts as may be agreed by a majority of its members as provided in the operating agreement of the company.

9. CONTINUITY: The remaining members may continue the business of the company as provided in the operating agreement upon the occurrence of an event, as defined by the operating agreement, which ends the term of the company.

10. TRANSFER OF INTEREST: A member's interest in the company is not subject to transfer, except as specifically provided in the operating agreement. A transfer made in violation of this provision is ineffective.

11. MANAGEMENT: The business of the company will be conducted under the exclusive management of its members, subject to the terms of the operating agreement.

12. AGENCY AUTHORITY: All authority to contract and otherwise act for the company is vested only in its members, subject to the terms of the operating agreement.


13. LIABILITIES OF MEMBERS: Members of the company are not liable under a judgment, decree or order of a court, or in any other manner, for a debt, obligation or liability of the company.

14. HEADINGS, GENDER AND NUMBER: The headings contained in these articles are for reference purposes only and will not affect the meaning or interpretation. Whenever the context requires, the gender of all words used in these articles will include the masculine, feminine and neuter, and the number of all words will include the singular and plural.

15. AMENDMENT OF ARTICLES AND OPERATING AGREEMENT: These articles of the company and its operating agreement may be amended by a majority vote of its members.
