WHEREAS, heretofore on November 15, 2004, **Jonathan S. Whitten, an unmarried man, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc., acting solely as nominee for International Mortgage Corp., successors and assigns**, which said mortgage is recorded in Instrument No. 20041123000644140, in the Office of the Judge of Probate of Shelby County, Alabama; and
