Commence at the Northeast corner of the NE ¼ of SE ¼ of Section 26, Township 21 South, Range 1 West; thence run South along the East line of said 1/4-1/4 section a distance of 302.14 feet; thence turn an angle of 86 degrees 10 minutes right and run a distance of 62.38 feet; thence turn an angle of 82 degrees 15 minutes right and run a distance of 100 feet; thence turn an angle of 82 degrees 15 minutes left and run a distance of 192.87 feet to the point of beginning; thence continue in the same direction a distance of 107.13 feet; thence turn an angle of 84 degrees 27 minutes right and run a distance of 175.00 feet; thence turn an angle of 95 degrees 59 minutes 30 seconds to the right and run a distance of 135.44 feet; thence turn an angle of 93 degrees 19 minutes 09 seconds to the right and run a distance of 173.51 feet to the point of beginning.
