Merrell, a married man, (herein referred to as grantor, whether one or more) grant, bargain, sell and convey unto, Joe Earl Merrell and Dorothy Merrell, (herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

South 1/3 of following described property:

All that part of the E ½ of E ½ of W ½ of NW ¼ of Section 17, Township 21, Range 2 West lying North of the Columbiana-Saginaw Road, except lot in Southeast corner heretofore conveyed to L. H. Driver, being described as follows: Beginning at a point on the North line of Columbiana public road where it intersects the East line of the W ½ of NW ¼ of Section 17, Township 21, Range 2 West and run North along said boundary line 135 feet; thence Westerly and parallel with the North line of said Columbiana road 250 feet; thence South and parallel with the East line of said W ½ of NW ¼ to the North line of said Columbiana road; thence Easterly with said road to the point of beginning; being situated in Shelby County, Alabama. 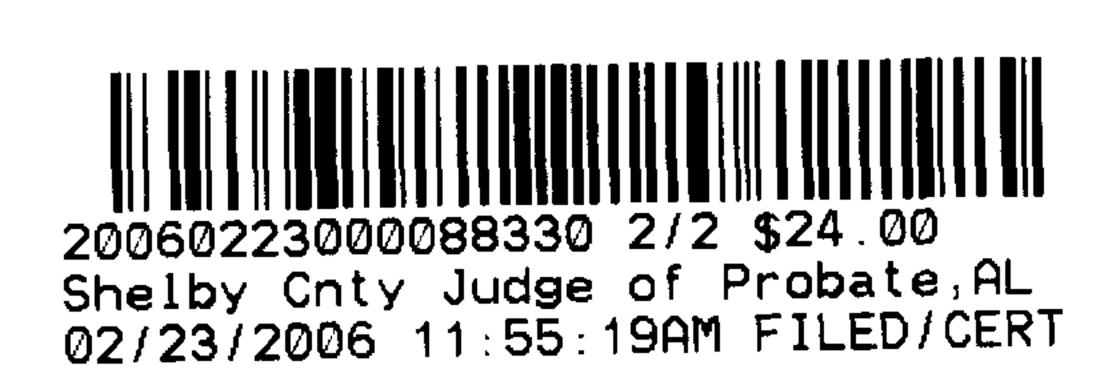
