STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS THAT in consideration of One Hundred Sixty Thousand One and No/100 Dollars (\$160,001.00), and other good and valuable consideration, paid to the undersigned grantor, Reba Caldwell, one and the same as Reva Caldwell, as Executrix of the Estate of Kathleen Smith Jones, deceased, Shelby County Case No. PR-2004-000179 ("Grantor"), by Tab Bisignani ("Grantee"), the receipt and sufficiency whereof are hereby acknowledged, Grantor does by these presents, grant, bargain, sell and convey unto the Grantee the following described real estate situated in Shelby County, Alabama (the "Premises"), to-wit:

Part of the NE ¼ of the SW ¼ of Section 13, Township 19 South, Range 2 West, in Shelby County, Alabama, more particularly described as follows: Commence at the SW corner of the NE ¼ of the SW ¼ of said Section 13 and run North along the West boundary line of said 1/4 1/4 section for 495 feet; thence turn an angle to the right of 92 deg. 24 min. and run Eastward parallel with the South boundary line of said 1/4 1/4 section a distance of 341.83 feet to a point on the Easterly right of way line of Cahaba Valley Road (having a width of 80 feet) for the point of beginning of the property herein described; continue Eastward along same course for a distance of 553.21 feet to a point on the Westerly right of way line of Oak Mountain Park Road (having a width of 80 feet); thence turn an angle to the right of 110 deg. 10 min. and run Southwesterly along the Westerly right of way line of Oak Mountain Park Road for a distance of 175.63 feet; thence turn an angle to the right of 69 deg. 50 min. and run Westward along a line which is 330 feet North of and parallel with the South boundary line of said NE ¼ of the SW ¼ of said Section for a distance of 563 feet to a point on the Easterly right of way line of aforesaid Cahaba Valley Road; thence to the right and run Northeasterly along the Easterly line of said road for a distance of 179.26 feet to the point of beginning. Being situated in Shelby County, Alabama.

Kathleen Smith Jones was the surviving grantee of that certain deed recorded in Deed Book 298, at Page 720, in the Probate Office of Shelby County, Alabama, A.A. Jones having died on or about May 9, 1998.
