**KNOW ALL MEN BY THESE PRESENTS**

That in consideration of **ONE HUNDRED EIGHTY THOUSAND and NO/00 Dollars (\$180,000.00)**, and other good and valuable considerations to the undersigned grantor, in hand paid by grantee herein, the receipt whereof is acknowledged, I or we,

grant, bargain, sell and convey unto,

**HANS SMITH AND AMY SMITH**

the following described real estate, situated in: SHELBY County, Alabama, to-wit:

Lot 19, Sector B, according to the survey of The Homestead, as recorded in Map Book 8, Page 167, in the Probate Office of Shelby County, Alabama.  
Situating in Shelby County.

Subject to restrictions, easements and rights of way of record.

This property constitutes no part of the homestead of the grantor, or of his spouse.

Subject to taxes for 2006 and subsequent years, easements, restrictions, rights of way and permits of record.
