WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

HOWARD and JENNIFER KIRKLAND HOWARD, HUSBAND AND WIFE, (herein referred to as GRANTOR(S), do hereby GRANT, BARGAIN, SELL and CONVEY unto DENINSON A. TORREALBA and ADRIENNE H.
