

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on June 24, 2003, Mark Alan Bean and Traci P. Bean, Husband and Wife, Party of the First Part, executed a certain mortgage to GMFS, LLC, which said mortgage is recorded in Instrument No. 20030715000448100, in the Office of the Judge of Probate of Shelby County, Alabama. Which said Mortgage was last sold, assigned and transferred to JPMorgan Chase Bank as Trustee, Party of the Second Part, said Assignment of Mortgage is recorded in Instrument No. 20040624000345020, in the Office of the Judge of Probate of Shelby County, Alabama.

WHEREAS, on May 4, 2006, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of WBH Investments, LLC in the amount of ONE HUNDRED THIRTY-SIX THOUSAND EIGHT HUNDRED FIFTY-ONE AND 00/100 DOLLARS (\$ 136,851.00); which the person conducting the sale on behalf of the mortgagee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to WBH Investments, LLC; and
