DISCLAIMER OF INTEREST

In accordance with §§43-8-290, et. seq., Code of Alabama (1975, as amended), I, Brooks Allan Suttle, being the grandson of Nell Jones Fulton, deceased, do by this Disclaimer of Interest definitely and finally disclaim, renounce and refuse to accept certain property which shall be described hereafter to which I am entitled under the terms and provisions of the Last Will and Testament of my deceased grandmother, which was probated in the Probate Court of Shelby County, Alabama, on February 7, 2006, and further identified by Case No. PR-2006-000076.

The property that I do hereby disclaim is as follows:

(1) I, the undersigned, Brooks Allan Suttle, hereby irrevocably and unqualifiedly refuse to accept any interest in any and all of the property which would otherwise pass to me under the Last Will and Testament of Nell Jones Fulton, deceased.

It is my intention that, by executing this Disclaimer of Interest, any rights or interest which I might otherwise have had in any and all of the property which would otherwise pass to me under the Last Will and Testament of Nell Jones Fulton, deceased, be terminated as completely as if I predeceased my said grandmother.

I confirm that I have not accepted any interest in or benefit from the property interest hereby disclaimed and renounced and that I have not received and I will not receive any consideration in money or monies worth for making this Disclaimer of Interest.

It is my intention that this Disclaimer of Interest comply with Code of Alabama (1975, as amended) §§43-8-290, et. seq., known as the "Alabama Uniform Disclaimer of Property Interests Act," and that it constitute a "qualified disclaimer" as defined in §§2518 of the Internal Revenue Code of 1986, as amended, and treasury regulations thereto.

It is my intent that my reason of this Disclaimer, that this disclaimed property shall pass to my uncle, Loyd Gerald Fulton, Jr., under the terms and provisions of the Last Will and Testament of Nell Jones Fulton, deceased.
