## ARTICLES OF ORGANIZATION

### OF

## BENJAMIN A. CRUNK, DDS, LLC

The undersigned, for the purpose of forming an limited liability company under Title 10, Chapter 12 of the *1975 Code of Alabama*, as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the probate judge of the county in which the initial registered agent of the limited liability company will be located and affirm that the facts stated in these Articles of Organization are true and correct:

### ARTICLE I

The name of the limited liability company is BENJAMIN A. CRUNK, DDS, LLC (the "Company").

### ARTICLE II

The period of duration of the Company shall be from the date of filing of these Articles of Organization with the Office of the Probate Judge for Shelby County, Alabama until the first to occur of the following:

- (a) Fifty (50) years from the date of filing of these Articles of Organization;
- (b) Dissolution of the Company pursuant to the laws of the State of Alabama or the Operating Agreement of the Company, as in effect from time to time; or,
- (c) Upon the written, unanimous consent of all the members of the Company.

### ARTICLE III

The purposes for which the Company is organized are as follows:

- (a) To engage in the practice of dentistry, dental surgery, and related dental care which is permitted under the laws of Alabama by those licensed and certified or otherwise permitted to practice and deliver such services.
- (b) To engage in the transaction of any or all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.

- (c) To borrow money and to evidence the same by notes or other evidences of indebtedness and to secure the same by mortgage, deed of trust, pledge or other lien or security interest in furtherance of any or all of the purposes of the Company.
- (d) To enter into, perform and carry out contracts and agreements necessary, appropriate or incidental to the accomplishment of the purposes of the Company; and,
- (e) To do any other acts or things that may be necessary, appropriate or incidental to the carrying out of the business and purposes of the Company, subject to the terms and conditions of any Operating Agreement entered into and executed by the Company's members.

#### ARTICLE IV

The location and mailing address of the initial registered office of the company shall be **955 Main Street, Montevallo, AL 35115**. The initial registered agent at the foregoing address shall be **Benjamin A. Crunk**.

#### ARTICLE V

The name and mailing address of the initial member of the company is as follows:

#### ARTICLE VI

The members of the Company shall have the right to admit additional members to the Company upon the unanimous consent of all the members of the Company.

#### ARTICLE VII

The members of the Company shall have the right to continue the business of the company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company, and such event shall not cause the dissolution of the company if:

- (i) there is a least one remaining member or at least one remaining member and a new member is admitted; and (ii) the legal existence and business of the Company is continued by a written consent of all the remaining members within 90 days after the member's cessation of membership.



### ARTICLE VIII


