3. Assignor warrants, represents, and covenants that there is now due on such judgment the sum of \$ 12,763.94 plus court costs of \$24.00, plus any allowable interest thereon from the date of judgment; Assignor shall not collect or receive any part thereof, nor release or discharge the judgment.


