

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas on April 13, 2005, Hester Development, Inc., a corporation, executed a certain mortgage on the property hereinafter described to Frontier Bank, said mortgage being recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument 20050506000216920; and

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage, and the said Frontier Bank did declare all of the indebtedness secured by said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper published in Shelby County, Alabama, in its issues of May 24, May 31 and June 7, 2006 with a sale date of June 15, 2006; and

WHEREAS, on June 15, 2006, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly and properly conducted, and Clay R. Carr was the Auctioneer who conducted said sale for Frontier Bank; and

WHEREAS, the highest and best bid for the property described in the aforementioned mortgage was the bid of Frontier Bank, in the amount of \$32,000.00 Dollars and said property was thereupon sold to Frontier Bank; and
