Know All Men by These Presents: That in consideration of **ONE HUNDRED THIRTY THREE THOUSAND ONE HUNDRED FIFTY AND NO/100 DOLLARS** (\$133,150.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **THE LORRIN GROUP**, **LLC** herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **BRYAN K. MORROW AND KARLA K. MORROW** (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 20, according to the Survey of Final Plat of The Meadows at Meriweather Phase 3, as recorded in Map Book 36, page 19, in the Probate Office of Shelby County, Alabama.

## Subject to:

\$126,492.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.


To Have And To Hold to the said grantees, as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantees, and, if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

The grantor covenants and agrees with the grantees that it is seized of an indefeasible estate in fee simple of said property, and that the grantor has the lawful right to sell and convey the same in fee simple; that the grantor is executing this Deed in accordance with the Articles of Organization and Operating Agreement of The Lorrin Group, LLC, which have not been modified or amended; that the property is free from encumbrances, and that the grantor and that its successors and assigns shall warrant and defend the same to the grantees, his, her or their heirs and assigns, against the lawful claims and demands of all persons.
