## ARTICLES OF ORGANIZATION OF RODGER'S PEST MANAGEMENT, L.L.C.

1. NAME OF COMPANY. The name of the Company is:

- 2. <u>PERIOD OF DURATION</u>. The period of duration of the Company shall be perpetual.
- 3. <u>COMPANY PURPOSES</u>. The Company has been organized in general to have and exercise any and all powers that corporations have and may exercise under the laws of the State of Alabama, and as the same may be amended, except such powers as are inconsistent with the express provisions of these Articles of Organization.


The Company has been organized for the purpose of purchasing, leasing, or otherwise acquiring by bequest, devise, gift, or other means, and to hold, own, manage, or develop, and to mortgage, hypothecate, deed in trust, sell, convey, exchange, option, subdivide, or otherwise dispose of real and personal property of every class and description and any estate, or interest therein, as may be necessary or convenient for the proper conduct of the affairs of the corporation, without limitation as to amount or value, in any of the states, districts, or territories of the United States, and in any and all foreign countries, subject to the laws of any such states, districts, territories, or countries.

The Company has been organized for the purpose of engaging in the business of pest control, fumigation, pest extermination and sterilization, and termite control, including the use of such chemicals as the corporation or its subsidiaries may be licensed and permitted to use, the preparation of escrow reports and the making of inspections as required, and the servicing of properties in the matter of extermination and fumigation in all phases of the work of pest control in whatever respect the corporation or its authorized subsidiaries may be licensed to do.

The Company has been organized for the purpose entering into and performance of all manner and kinds of contracts, agreements, and obligations for any lawful purpose by or with any person, firm, association, corporation, or governmental division or subdivision.

The Company has been organized to conduct and carry on its business or any branch thereof in any state or territory of the United States or in any foreign country in conformity with the laws of such state, territory, or foreign country, and to have and maintain in any state, territory, or foreign country a business office, plant, store or other facility.

The Company has been organized to engage in the to buy, sell, and hold real and personal



property in any state or territory necessary for the proper conduct of its business and to do such other things and have such other and further powers as are necessary and incidental to carrying out the general business of the Company.

The Company may also transact any other lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company.
