

## ARTICLES OF ORGANIZATION

### FOR

# GALAXY CONTRACTORS, A LIMITED LIABILITY COMPANY

The undersigned, acting as organizers of a Limited Liability Company, pursuant to the Alabama Limited Liability Company Act (the "Act") and all applicable amendments thereto, hereby adopt the following Articles of Organization:

## **ARTICLE I**

### NAME

The name of the Limited Liability Company (the "Company") shall be Galaxy Contractors, L.L.C.

### ARTICLE II

## **DURATION**

The period of duration of the Limited Liability Company shall continue in existence for the lives of the members or until it is dissolved in accordance with these articles or with the Alabama Limited Liability Company Act and any amendments thereto.

### ARTICLE III


## **PURPOSES**

## ARTICLE VI

## ADMISSION OF ADDITIONAL MEMBERS

No person may be admitted as an additional member without the approval all members.

## ARTICLE VII

## CONTINUATION OF BUSINESS

Upon the occurrence of an event of disassociation which terminates the continued membership of a member, the remaining members may continue the legal existence and business of the Company if (1) there is at least one remaining members or a new member is admitted, and (2) a majority in interest of the members consent in writing to the continuation of business within ninety (90) days after the occurrence of the event of disassociation.

### ARTICLE VIII

#### MANAGEMENT

The Company shall be managed by managing member Waleed Ghabayen.

#### ARTICLE IX

#### **POWERS**

The limited liability company shall have all powers given to limited liability companies by the Alabama Limited Liability Company Act and such other acts or laws as may be applicable to limited liability companies in the state of Alabama and such other jurisdictions in which this limited liability company may be doing business.
