DOMESTIC LIMITED LIABILITY COMPANY ARTICLES OF ORGANIZATION GUIDELINES

INSTRUCTIONS:

STEP 1: THE NAME OF THE LIMITED LIABILITY COMPANY MUST CONTAIN THE WORDS LIMITED LIABILITY COMPANY, LLC OR L.L.C.

STEP 2: FILE THE ORIGINAL AND TWO COPIES OF THE ARTICLES OF ORGANIZATION IN THE COUNTY WHERE THE LLC'S REGISTERED OFFICE IS LOCATED. THE SECRETARY OF STATE'S FILING FEE IS \$40. PLEASE CONTACT THE JUDGE OF PROBATE TO VERIFY THE PROBATE FILING FEE.

PURSUANT TO THE ALABAMA LIMITED LIABILITY COMPANY ACT, THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF ORGANIZATION.

Article I The name of the Limited Liability Company:
Dream Homes LLC

(Your company title must end with the words Limited Liability Company, L.L.C. or LLC)

Article II The duration of the Limited Liability Company is 30 years.

Article III The Limited Liability Company has been organized for the following purpose(s):
To engage in any lawful business for which limited liability companies may be organized in this state.

Article IV The street address (NO PO BOX) of the registered office: 5010 Applecross Road, Birmingham, AL 35242 and the name of the registered agent at that office: David B. Jones

Article V The names and addresses of the initial member(s), and organizer (if any):

Article VI If the Limited Liability Company is to be managed by one or more managers, list the names and addresses of the managers who are to serve until the first annual meeting of the members or until their successors are elected and qualified.

Any provision that is not inconsistent with the law for the regulation of the internal affairs of the Limited Liability Company is permitted to be set forth in the operating agreement of the LLC.

LLC Operating Agreement for Single-Member LLC

1. Names

This operating agreement is made by Dream Homes LLC, an Alabama limited liability company (Company), and David B. Jones (Member).

2. Formation

The Company has been formed under the Alabama statute authorizing the formation of limited liability companies. The purpose of the Company is stated in the articles of organization.

3. Offices

The Company will have one or more offices at places the Member designates. The initial registered office of the Company is located at:

5010 Applecross Road
Birmingham, Alabama 35242

and the Member is the resident agent.

4. Management

The Member has the right to manage the Company's business. The Member may delegate to another person the authority to perform specified acts on behalf of the Company. If the Member dies or is unable to act, the Company will be managed by Donna J. Jones or by the person the Member last designates in writing to manage the Company. That person will have full authority to manage the Company until the Member can do so.

5. Capital Contributions

The Member will contribute \$1,000 to the Company in exchange for the Member's ownership interest in the Company. The Member will not be paid interest on this capital contribution.

6. Taxes

For federal tax purposes, the Company will be taxed as a sole proprietorship, with profits and losses passing through to the Member.

7. Funds

The Member will determine the financial institution that will hold Company funds and will determine the authorized signatures on Company accounts.

8. Additional Members

The Company may admit one or more additional members upon such terms as are determined by the Company and the Member. If new members are admitted, the articles of organization and the operating agreement will be appropriately amended.

9. Distributions

The Member will determine when and how cash and other assets of the Company will be distributed.


