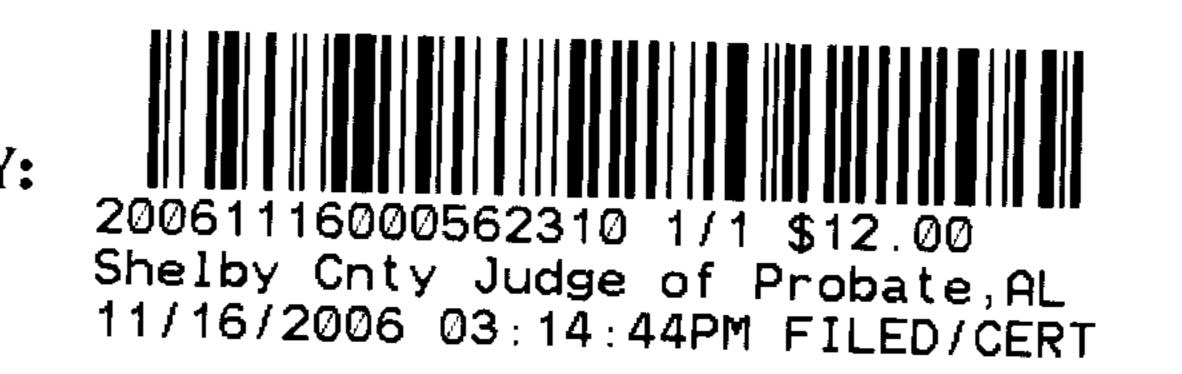

WARRANTY DEED JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

STATE OF ALABAMA SHELBY COUNTY

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One Dollar (\$1.00) in hand and paid to the undersigned and other good and valuable consideration, the receipt whereof is hereby acknowledged, the undersigned, John T. Klinner and Linda C. Klinner, husband and wife, (hereinafter called GRANTORS) hereby grant, bargain, sell, and convey to John T. Klinner and Linda C. Klinner, husband and wife, (hereinafter called GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all their rights, title, interest, and claims in or to the following described real estate, situated in Shelby, Alabama, to-wit:

Lots 1 and 2, and South 18 feet and 11 inches off of Lot 3 in Block 1, according to Nicherson-Scott Survey, as recorded in Map Book 3 Page 34 in the Probate Office of Shelby County, Alabama.

This conveyance is made subject to any and all mortgages, liens, covenants, restrictions, reservations and easements affecting said properties, which appear of record in the Office of the Judge of Probate of Shelby County, Alabama. No title search, opinion or survey has been provided, supplied or relied upon by the Grantees or the preparer of this deed and there is no certification as to the merchantability of the title to the land described.
