MEMORANDUM OF EXCLUSIVE PROPERTY MANAGEMENT AGREEMENT
[Shelby County, Alabama]

THIS MEMORANDUM OF EXCLUSIVE PROPERTY MANAGEMENT AGREEMENT
(this "Memorandum") is made effective as of November 21, 2006, by and between

WINN-DIXIE MONTGOMERY LEASING, LLC, a Florida limited liability company ("Tenant"), whose address for purposes of notice is 5050 Edgewood Court, Jacksonville, Florida 32254, Attention: Legal Department, and

WINN-DIXIE MONTGOMERY, INC., a Florida corporation ("Manager"), whose address for purposes of notice is 5050 Edgewood Court, Jacksonville, Florida 32254, Attention: Legal Department.

RECITALS:

- A. Tenant is the successor lessee under certain leases as more particularly described on attached Exhibit A (the "Leases"), covering the leased premises as described therein (the "Premises"), each and every such Premises being located in Shelby County, Alabama.
- B. Tenant and Manager have entered into that certain Exclusive Property Management Agreement dated effective as of November 21, 2006 (the "Management Agreement"), pursuant to which Manager has the right to physical possession of the Premises as the operator and manager thereof.
- C. Tenant and Manager desire to place third parties on notice of the existence of the Management Agreement.

ACCORDINGLY, Tenant and Manager hereby certify and state the following:

- 1. **Management Agreement.** Notice is hereby given that, pursuant to the Management Agreement, Tenant has engaged Manager as its manager and operator with respect to the Premises, and that in such capacity, Manager will have the right and privilege to maintain physical possession of the Premises pursuant to the Management Agreement for the purpose of operating and managing the Premises in the ordinary course of Manager's business.

- 3. **Record Notice.** This instrument is intended to place third parties on record notice of Manager's possessory rights in the Premises pursuant to the Management Agreement.

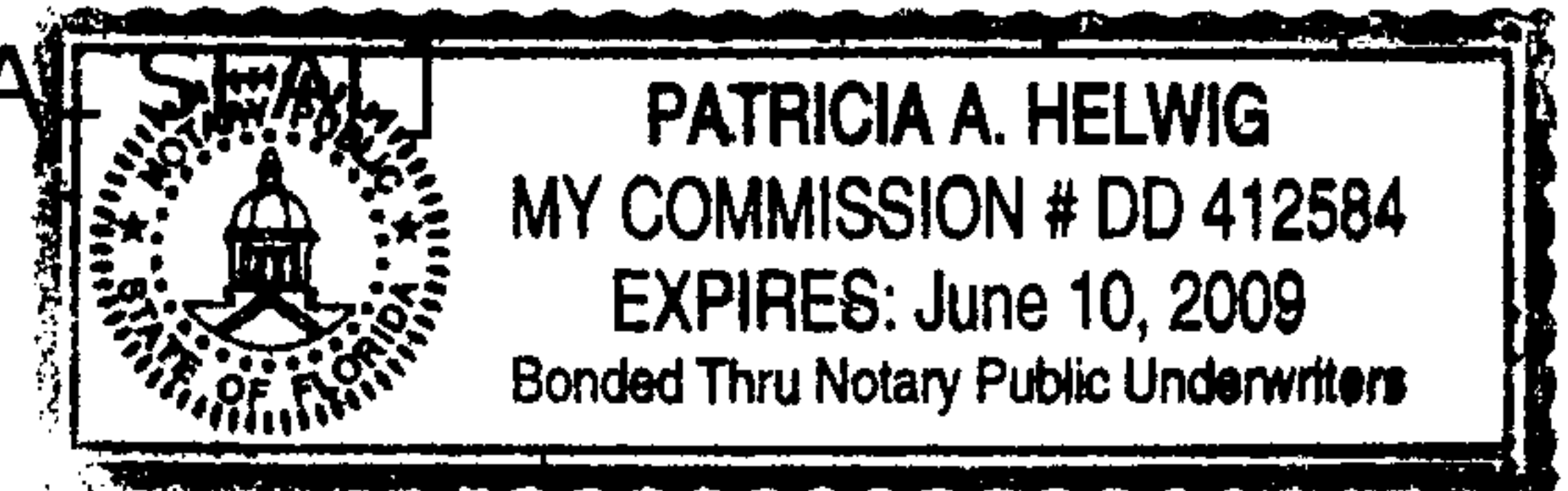

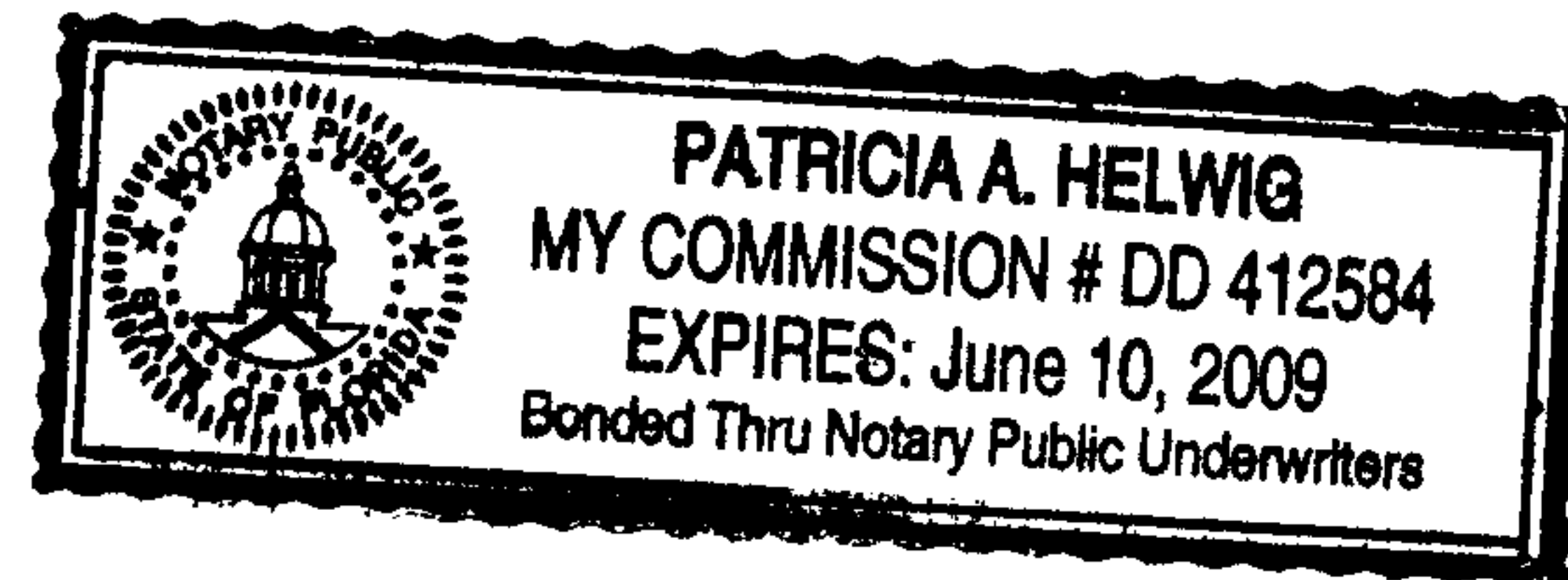

