Begin at the Southwest Corner of the N ½ of the SW ¼ of the NE ¼ of Section 2, Township 21 South, Range 3 West, and run Easterly along the South side of the said N ½ for 790.66 feet to the point of beginning; then continue along the last described course for 342.22 feet; thence turn an angle of 57 degrees 13 minutes 19 seconds to the left and run Northeasterly for 26.54 feet; thence turn an angle of 84 degrees 09 minutes 30 seconds to the left and run northwesterly for 894.71 feet, then turn an angle of 107 degrees 39 minutes 31 seconds to the left and run southwesterly for 244.52 feet; then turn an angle of 72 degrees 20 minutes 29 seconds to the left and run southeasterly for 292.51 feet; then turn an angle of 90 degrees 00 minutes to the right and run southeasterly for 7.00 feet; then turn an angle of 90 degrees 00 minutes to the left and run southeasterly for 263.34 feet back to the point of beginning.
