

# ARTICLES OF ORGANIZATION

OF

## WEYGAND INSURANCE AGENCY, LLC AN ALABAMA LIMITED LIABILITY COMPANY

Pursuant to the Provisions of Code of Alabama, Title 10, Chapter 12, Article 1, et. seq., the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

### ARTICLE I

#### Name

The name of the Limited Liability Company is: **WEYGAND INSURANCE AGENCY, LLC, an Alabama Limited Liability Company** (hereinafter referred to as the "Company").

### ARTICLE II

#### Duration

The Company shall begin on the filing of the Articles of Organization with the Probate Judge and shall continue perpetually; provided however, the Company shall be dissolved prior to such date upon the earlier to occur of 1. the written consent of all members to dissolve the Company; 2. as may be provided in an operating agreement created at a later date; or 3. as may be required under the LLC Act.

### ARTICLE III

#### Purposes

The Company has been organized for the purpose of operating an insurance brokerage business in the State of Alabama and performing all other legal business matters appertaining thereto.

### ARTICLE IV

#### Registered Agent/Office

**Admission of New Members**


The initial Member has the right to admit additional Members, upon such terms and conditions as may be agreed upon by the initial Member of the Company.
