

## AUCTIONEER'S DEED

## STATE OF ALABAMA COUNTY OF SHELBY

WHEREAS, JUAN NUNEZ and GABRIELLA NUNEZ, a married couple executed a mortgage to Mortgage Electronic Registration Systems, Inc. 
