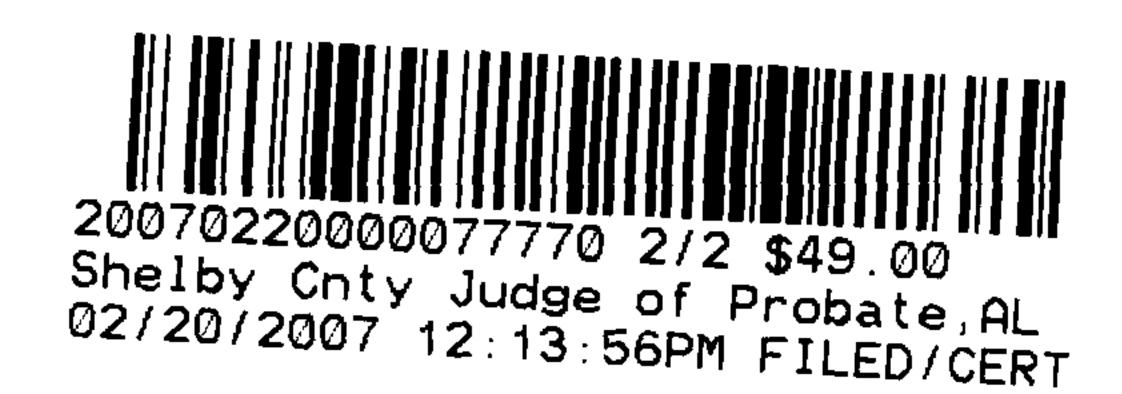

All of Lot 83 and a part of Lot 82, according to the Survey and Map of a Resubdivision of Lots 82, 83 and 84, Braelinn Village, Phase IV, as recorded in the Office of the Judge of Probate, Shelby County, Alabama in Map Book 14, Page 37, and being more particularly described as follows: Beginning at the most Easterly corner of said Lot 82, which is a common corner with Lot 83 of said Resubdivision and also being on the West right of way line of O'Connor Court, run North 57 degrees 07 minutes 13 seconds West along the common line between said Lots 82 and 83 for a distance of 80.0 feet; thence turn an angle to the left of 39 degrees 25 minutes 01 seconds and run in a Southwesterly direction for a distance of 87.57 feet to an existing iron pin; being a common corner of said Lots 82 and 83; thence turn an angle to the left of 161 degrees 11 minutes 33 seconds and run in a Southeasterly direction for a distance of 70.50 feet to an existing iron pin; thence turn an angle to the right of 7 degrees 28 minutes 51 seconds and run in a Southeasterly direction for a distance of 28.75 feet, to the point of beginning; being situated in Shelby County, Alabama.
