KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Three Hundred Seven Thousand and no/100 Dollars (\$307,000.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **JOEL C. REED and wife, MINDY REED**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **DOUGLAS P. MILES and SUSAN E. MILES**, as joint tenants with rights of survivorship, (herein referred to as "Grantees") their interest in the following described real estate situated in Shelby County, Alabama, to wit:

Lot 337, according to the Survey of Caldwell Crossings, Third Sector, as recorded in Map Book 33, Page 154, in the Probate Office of Shelby County, Alabama. Situated in Shelby County, Alabama.


Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2007 and subsequent years not yet due and payable.

AND THE GRANTOR does for their heirs and executors, successors and assigns, covenant with said Grantees, their heirs, executors, successors and assigns, that Grantor is lawfully seized in fee simple of the premises, that they are free from all encumbrances, unless otherwise noted above, that Grantor has good right to sell and convey the same as aforesaid, and that Grantor will and their heirs and executors, successors and assigns shall warrant and defend same to said Grantees, their heirs, executors, successors and assigns forever, against the lawful claims of all persons.

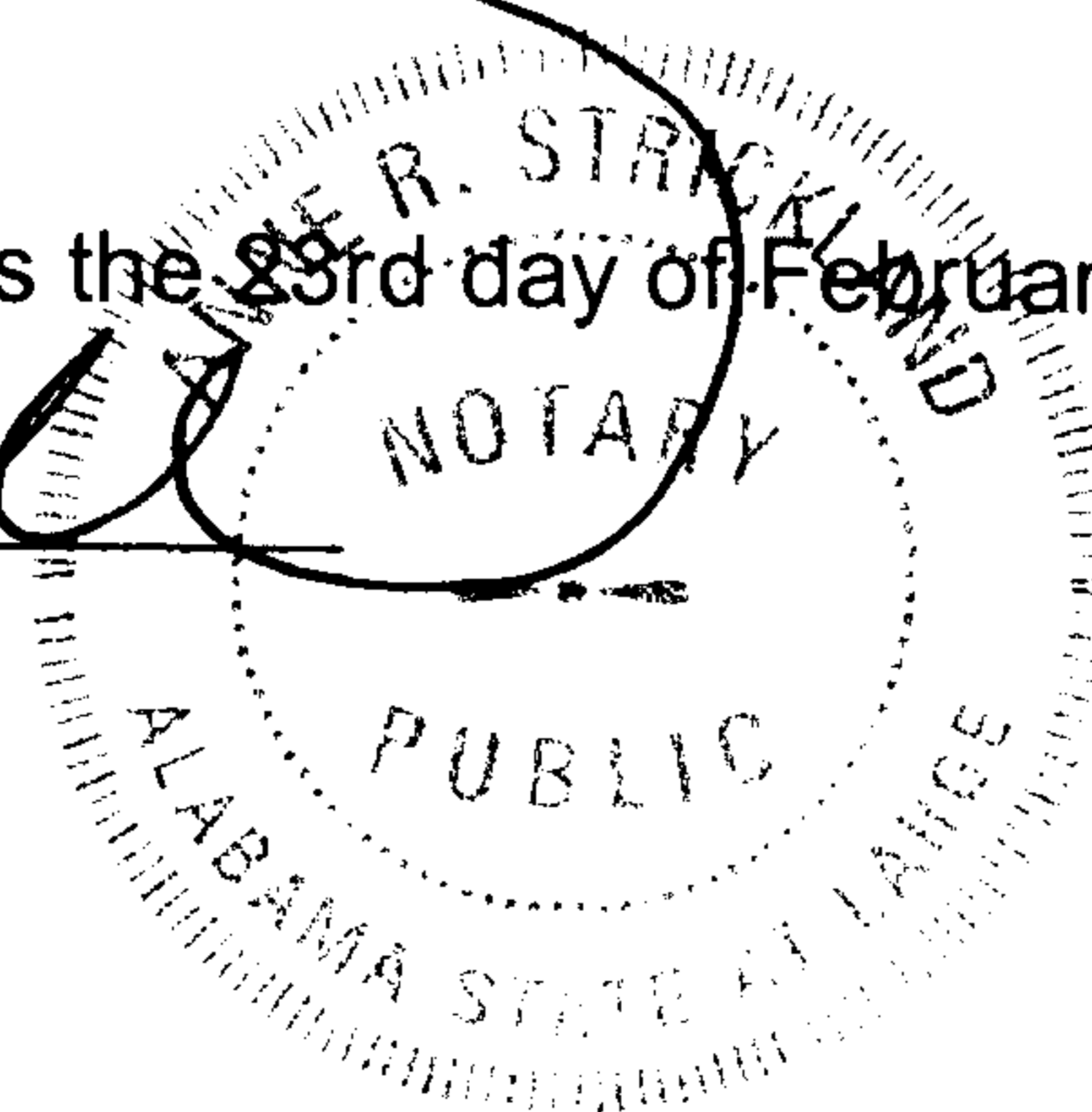
