KNOW ALL MEN BY THESE PRESENTS, that in consideration of One Dollar and other good and valuable consideration, to the undersigned grantor, **Tanglewood Corporation**, an Alabama corporation, in hand paid by the grantees herein, the receipt whereof is acknowledged, the said **Tanglewood Corporation**, does by these presents, grant, bargain, sell and convey unto **Guy C. Alexander and Susan P. Alexander** (herein referred to as Grantees) as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 1915 of the survey of Old Cahaba, Phase V, First Addition, as corrected and re-recorded in **Map Book 38, Page 46** in the Office of the Judge of Probate of Shelby County, Alabama. Together with all improvements situated thereon.

Subject to the restrictions recorded in the Office of the Judge of Probate of Shelby County, Alabama, at Instrument No. 2005091600048160.

Subject to those matters set forth on subdivision plat of said property as recorded in Map Book 35, Page 120, and **Resurvey of Lots 1914, 1915, and 1916**, in the Office of the Judge of Probate of Shelby County, Alabama.

This deed is given to correct the legal description in and replace the deed from Grantor to Grantee recorded at Instrument No. 20070129000042200.

TO HAVE AND TO HOLD unto the said Grantees, as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And Tanglewood Corporation, does for itself, its successors and assigns, covenant with said Grantees, their heirs and assigns, that it is lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise stated above; that it has a good right to sell and convey the same as aforesaid; and that it will, and its successors and assigns shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.
