
Together with all and singular the tenaments, hereditaments

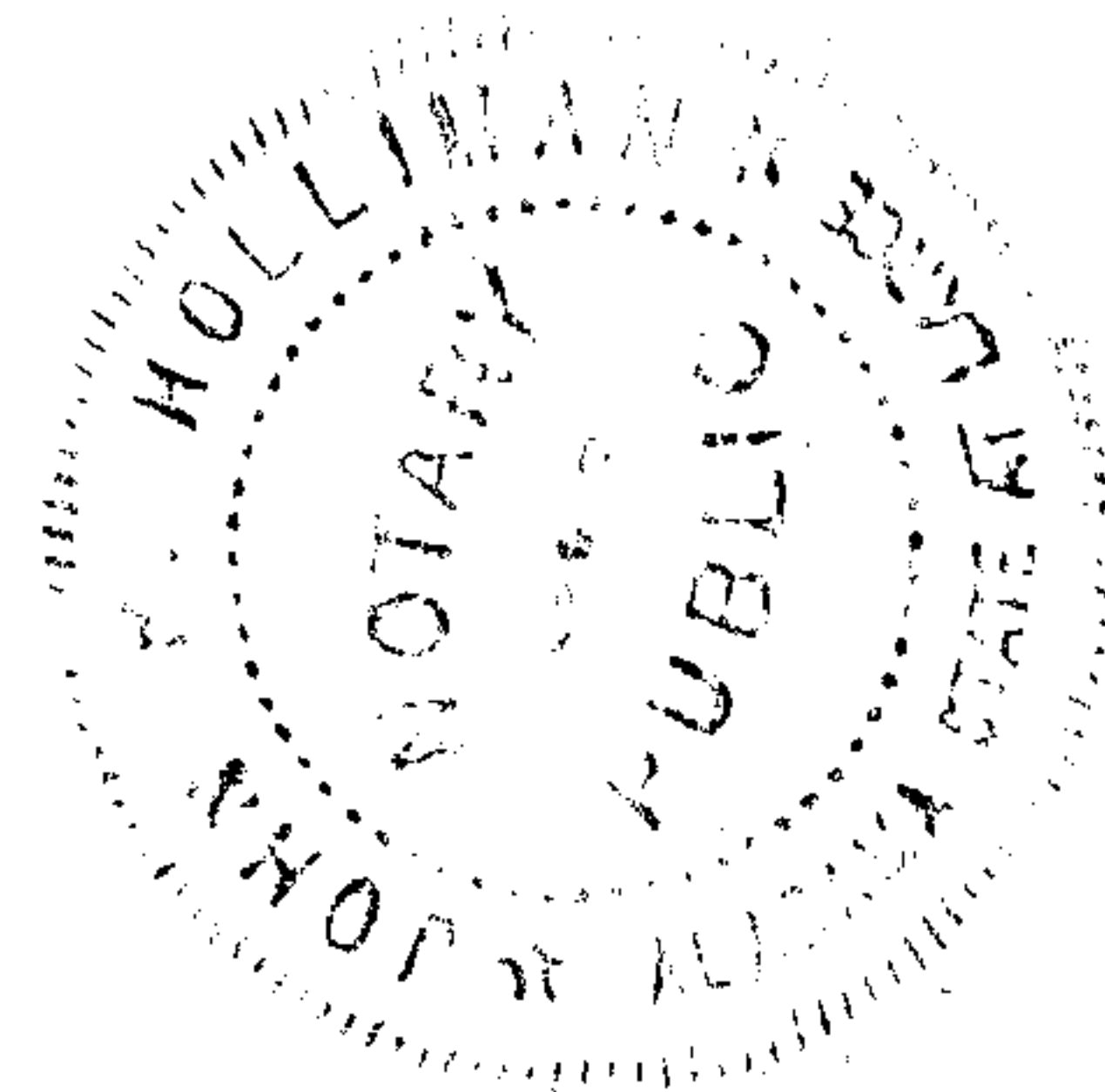
