

Pursuant to the provisions of Section 11-42-21 of the Code of Alabama (1975),

Whereas, the attached written petition requesting that the above-noted property be annexed to the City of Chelsea has been filed with the Chelsea City Clerk; and

Whereas, said petition has been signed by the owner(s) of said property; and

Whereas, said petition contains (as Petition Exhibits A&B) an accurate description of said property together with a map of said property (Exhibit C) showing the relationship of said property to the corporate limits of Chelsea, and a copy of the metes and bounds (Exhibit D); and


Whereas, said property is contiguous to the corporate limits of Chelsea, or is a part of a group of properties submitted at the same time for annexation, which is zoned AR which together is contiguous to the corporate limits of Chelsea;

Whereas, said territory does not lie within the corporate limits of any other municipality;

Whereas, even though said property is located in an area where the police jurisdiction of Chelsea and the police jurisdiction of Westover overlap, the said property is less than equidistance from the respective corporate limits of Chelsea and Westover (i.e. it is closer to the corporate limits of Chelsea than to the corporate limits of Westover).


Therefore, be it ordained that the City Council of the City of Chelsea assents to the said annexation: and



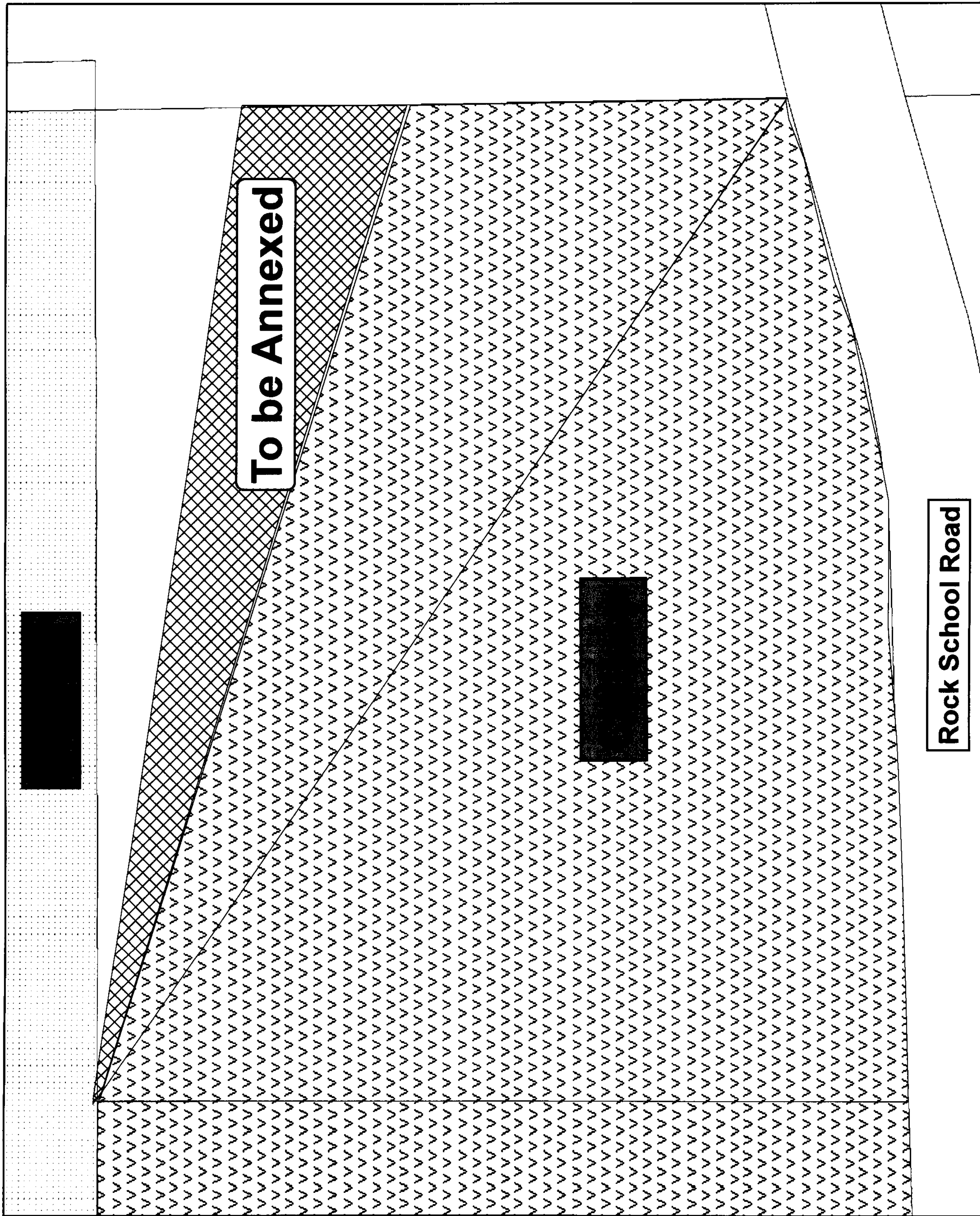

**PROPOSED ANNEXATION
CITY OF CHELSEA
COOLIDGE ISBELL AND FRANCIS LYNN ISBELL PROPERTY**

TRACT 18:

Beginning at the NW corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 32, Township 19 South, Range 1 East, Shelby County, Alabama; thence run in an Easterly direction along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 890 feet, more or less, to a point; thence run South a distance of 5.69 feet to a point; thence continue South a distance of 359 feet, more or less, to a point on the North right of way Shelby County Hwy #450, said point lying on a curve to the left having a radius of 1,400.11 feet and a central angle of 19 degrees 56 minutes 01 seconds; thence run Easterly along the arc and along said right of way a distance of 487.11 feet to a point on the East line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section; thence North along the East line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 128 feet, more or less, to a point to the point of beginning; thence continue North along said East line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 64 feet, more or less, to a point; thence run in a Northwesterly direction 435 feet, more or less, to a point lying 890 feet East and 5.69 feet South of the NW corner of said $\frac{1}{4}$ - $\frac{1}{4}$ Section; thence run in a Southeasterly direction a distance of 440 feet, more or less, to the point of beginning.
