THIS FORECLOSURE DEED made this 5<sup>th</sup> day of June, 2007, between FRANK K. HOWELL and MICHELLE HOWELL, husband and wife, Parties of the First Part, and DEUTSCHE BANK NATIONAL TRUST COMPANY, AS TRUSTEE OF AMERIQUEST MORTGAGE SECURITIES, INC., ASSET-BACKED PASS THROUGH CERTIFICATES, SERIES 2004-R7, UNDER THE POOLING AND SERVICING AGREEMENT DATED AS OF JULY 1, 2004, Party of the Second Part;

W I T N E S S E T H:

WHEREAS, the said FRANK K. HOWELL and MICHELLE HOWELL, husband and wife, heretofore executed to AMERIQUEST MORTGAGE COMPANY, herein called the Mortgagee, a certain mortgage dated June 11, 2004, and recorded in Instrument Number 20040630000361110, Probate Records of Shelby County, Alabama, which conveyed the hereinafter described property to secure the indebtedness evidenced by a note, payable in installments, therein described; and
