**ARTICLES OF ORGANIZATION
OF
WRH, L.L.C.**

The undersigned organizers adopt the following Articles of Organization for the limited liability company named below pursuant to the Code of Alabama 1975, Title 10, Chapter 12, also know as the "Limited Liability Company Act."

ARTICLE I

1.01 The name of the Limited Liability Company shall be WRH, L.L.C.

ARTICLE II

2.01 The period of duration is perpetual.

ARTICLE III

3.01 **WRH, L.L.C.** is organized for the business of consulting and design work and to engage in all other business permitted under the laws of the State of Alabama.

ARTICLE IV

ARTICLE VI

Right to Admit New Members, Terms, and Conditions of Admission

- 6.01 **Right to Admit New Members.** The current members listed in Article V reserve the right to admit additional members. The new member must receive a unanimous vote of approval from the current members.

ARTICLE VII

Continuing the Business After a Dissociation

- 7.01 **Reservation of Right.** After any event of dissociation that may terminate the continued membership of a member, the remaining member(s) listed in article V reserve the right to continue the business without interruption. There must be unanimous consent among the remaining member(s) to continue. Nothing in the clause will be construed to mean that the Limited Liability Company must continue business after any event of dissociation.

ARTICLE VIII

Name and address of the Initial Manager



ARTICLE IX


Other Provisions
