That in consideration of **Five Hundred Seventy-five Thousand and 00/100 Dollars (\$575,000.00)** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt whereof is acknowledged,

**Ronald B Barrow and Kathleen Barrow, husband and wife**  
(herein referred to as GRANTOR, whether one or more) do, grant, bargain, sell and convey unto

**Edgar Shields Frey and Page F Frey**  
(herein referred to as GRANTEE, whether one or more), the following described real estate situated in Shelby County, Alabama, to-wit:

**Lot 63-A, according to the Resurvey of Lots 63 and 64 of High Hampton, Sector 2, as recorded in Map Book 30, page 84, in the Probate Office of Shelby County, Alabama.**

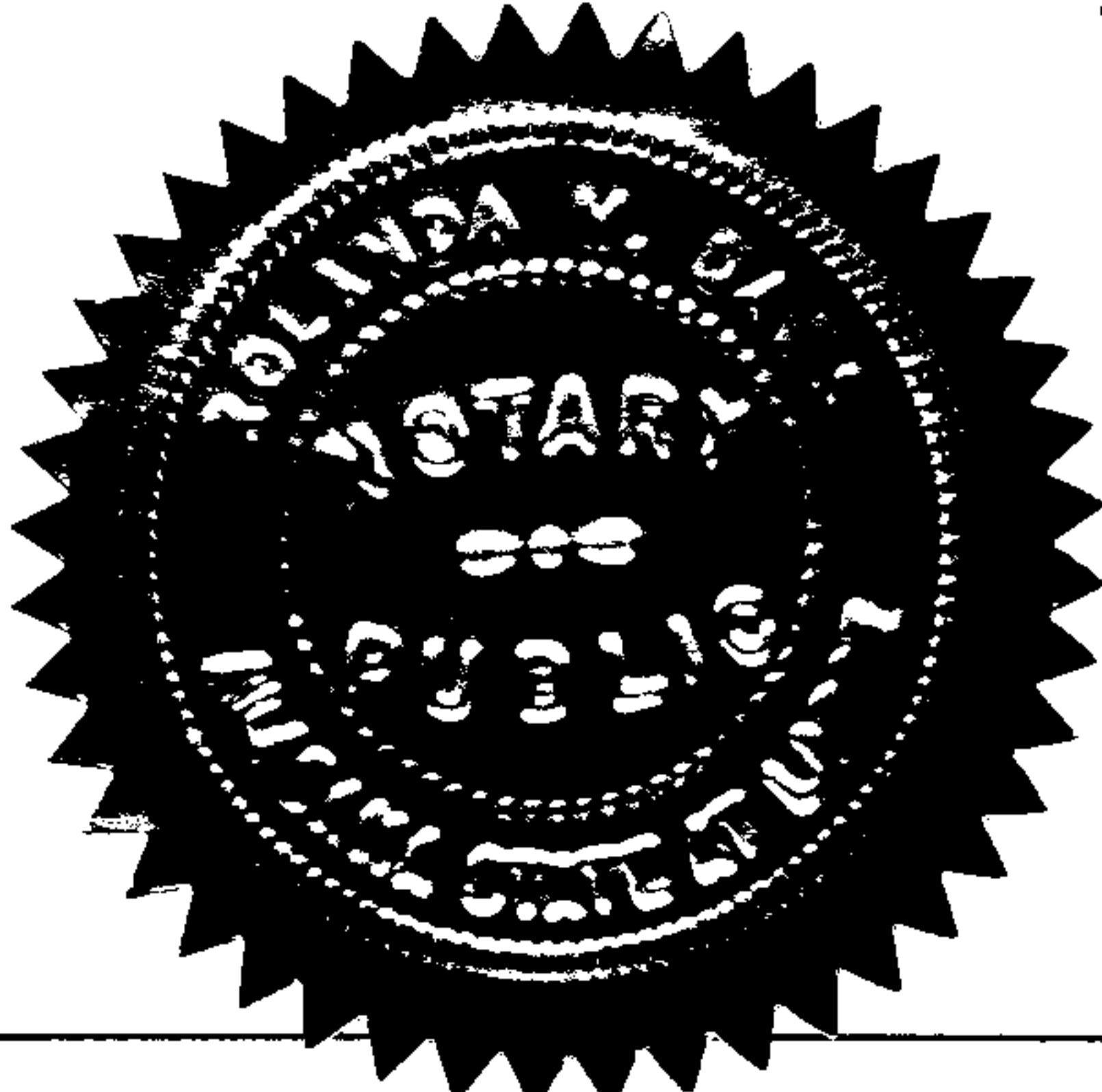
