KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 25th day of October, 2001, Willie L. Shephard and wife, Valerie Shephard, executed that certain mortgage on real property hereinafter described to Liberty Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument #2001-46705, said mortgage having subsequently been transferred and assigned to Countrywide Home Loans, Inc., by instrument recorded in Instrument #2001-55991, in the aforesaid Probate Office; and


