STATUTORY WARRANTY DEED

KNOW ALL PERSONS BY THESE PRESENTS, that in consideration of One Hundred Seventy-Four Thousand Nine Hundred no/100 Dollars (\$174,900.00) to the undersigned Holland Lakes, Inc., an Alabama corporation ("Grantor"), in hand paid by Thomas E. Hunter ("Grantee"), the receipt and sufficiency of which are hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Grantee the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 14, according to the final plat of Holland Lakes, Sector 1, as recorded in Map Book 34 Page 85 in the Probate Office of Shelby County, Alabama (the "Property").
