### SPECIAL POWER OF ATTORNEY TO RELEASE CHATTEL AND REAL ESTATE MORTGAGES

**WHEREAS**, the by-laws of Wells Fargo Financial Alabama Inc., f/k/a Norwest Financial Alabama, Inc. (the "Corporation"), an Alabama corporation, duly and legally adopted and now in full force and effect, provide among other things as follows:

That the Corporation grants and gives unto said attorney, full authority and power to do and perform all and every act and thing whatsoever requisite and necessary to be done in the premises, as fully to all intents and purposes, as it might or could do if personally present, hereby ratifying and confirming all that said attorney shall lawfully do or cause to be done by virtue thereof.
