MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on July 13, 2001, **Walter Butler, a married and wife, Julie T. Butler, Party of the First Part**, executed a certain mortgage to **ABN AMRO MORTGAGE GROUP, INC.**, which said mortgage is recorded in Instrument No. 2001-31169, in the Office of the Judge of Probate of Shelby County, Alabama ; and

WHEREAS, default in the payment of the indebtedness secured by said mortgage, and ABN AMRO MORTGAGE GROUP, INC. did declare all of the indebtedness secured by the said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage, in accordance with the terms thereof, by publication in the Shelby County Reporter, a newspaper of general circulation in Shelby County, Alabama, in its issues of 4/4/2007, 4/11/2007, 4/18/2007, 5/2/2007 and 6/13/2007.; and

WHEREAS, on July 12, 2007, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of ABN AMRO MORTGAGE GROUP, INC. in the amount of **ONE HUNDRED THIRTY-FOUR THOUSAND SIX HUNDRED SIXTY-TWO AND 15/100 DOLLARS (\$ 134,662.15)**; which the person conducting the sale on behalf of the mortgagee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to ABN AMRO MORTGAGE GROUP, INC.; and

WHEREAS, Mikki Prince, conducted said sale and acted as auctioneer thereat, under and pursuant to an appointment as such by the Party of the Second Part; and

TO HAVE AND TO HOLD the above described property unto ABN AMRO MORTGAGE GROUP, INC., its successors and assigns forever; subject however to the statutory right of redemption on the part of those entitled to redeem as provided by the laws of the State of Alabama; also subject to ad valorem taxes, easements and/or restrictions of record, prior liens and/or assessments of record.
