**Articles of Organization  
Of  
HASTY COMPLETE SERVICES, LLC  
An Alabama Limited Liability Company**

Pursuant to the Provisions of Sections 10-12-1, et seq. of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

**ARTICLE I**

**Name**

The name of the limited liability company is Hasty Complete Services, LLC, an Alabama Limited Liability Company (the "Company").

**ARTICLE II**

**Duration**

The Company shall have duration from the date of organization until it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act").

**ARTICLE III**

**Purposes**

The purpose for which the Company has been organized is to engage in any lawful act or activity for which limited liability companies may be organized pursuant to the Act.

**ARTICLE IV**

**Registered Office, Registered Agent**


## ARTICLE VII
