### FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of December 2005, Christopher G. Guffey and Jennifer L. Guffey, husband and wife, executed that certain mortgage on real property hereinafter described to IWayLoan, LP, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20060104000005100, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., by instrument recorded in 20060118000027800, in the aforesaid Probate Office; and
