**ARTICLES OF ORGANIZATION**  
**OF**  
**OLD SKOOL FAMILY BIZNIZZ, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the probate office of the county in which the initial registered office of the limited liability company will be located and hereby affirm the facts stated herein are true and correct:

**ARTICLE I**

**NAME**

The name of the limited liability company is **OLD SKOOL FAMILY BIZNIZZ, L.L.C.** (the "Company").

**ARTICLE II**

**DURATION**

The term of the Company shall be perpetual from the date of the filing of these Articles of Organization with the probate office of the county in which the initial registered office of the Company is located, unless the Company is earlier dissolved in accordance with the operating agreement of the Company or the Alabama Limited Liability Company Act.

**ARTICLE III**

**PURPOSES**

The purpose or purposes for which the Company is organized is the transaction of any or all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act.

Specifically included among the purposes for which this company is organized, without in any way limiting or restricting said purposes as set out above, are the following:

(a) To engage in the business and profession of applying Body Art and tattoos and the piercing of the human body and to own and operate one or more tattoo studios and businesses.

(b) To purchase, own, construct, improve, develop, lease, exchange, sell, dispose of, invest in and otherwise deal in and turn to account, real estate; to purchase, lease, build, construct, erect, renovate, occupy, and manage buildings of every kind and character whatsoever; to finance the purchase, improvement, development, and construction of land and buildings belonging to or to be acquired by this company, or any other person, firm, or corporation.

(c) To manufacture, produce, purchase or otherwise acquire, hold, own, sell, mortgage, pledge, transfer or otherwise dispose of, to invest, trade, deal in and deal with, goods, wares and merchandise and real and personal property of every class and description.

(d) To provide services and consultation to and for and to enter into, make and perform contracts with any person, firm, company, association or corporation.

(e) To acquire, build, operate, conduct, manage, maintain and carry on the business organizations, structures and facilities required or desired in order to perform the aforesaid purposes and generally to do everything necessary or desirable for carrying out said purposes.

#### ARTICLE IV

##### REGISTERED AGENT/OFFICE

The location and street address of the initial registered office of the Company is **3180-A Pelham Parkway, Pelham, Alabama 35124** and the name of its initial registered agent at such address is **Jason Jeffrey Browning**.

#### ARTICLE V
