**ARTICLES OF ORGANIZATION
OF
ALABAMA FAMILY CARE, LLC**

The undersigned, for the purpose of forming a limited liability company under ALA. CODE, Section 10-12-1, et seq., (1975), as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the Probate Judge of the county in which the initial registered office of the limited liability company will be located and affirm that the facts stated in these Articles of Organization are true and correct:

ARTICLE I

NAME OF COMPANY: The name of the limited liability company is **Alabama Family Care, LLC (the "Company")**.

ARTICLE II

DURATION: The period of duration of the Company shall be perpetual from the date of filing of these Articles of Organization with the Office of the Probate Judge for Shelby County, Alabama, until such time as the Company may be dissolved pursuant to the laws of the State of Alabama or the Operating Agreement of the Company, as in effect from time to time.

ARTICLE III

PURPOSES AND POWERS: The purpose for which the Company is organized is to provide in home non-medical personal care and any other lawful purpose for limited liability companies organized and existing by virtue of the laws of the State of Alabama. Additionally, the Company shall have all the powers vested in a limited liability company organized and existing by virtue of the laws of the State of Alabama.

ARTICLE IV

REGISTERED OFFICE AND AGENT FOR SERVICE OF PROCESS: The location and mailing address of the initial registered agent of the Company shall be 1848 Trailridge Drive, Pelham, Alabama 35124. The initial registered agent for service of process at the foregoing address shall be Christopher F. Jane.

CONTINUITY OF BUSINESS: The cessation of membership of one or more Members for any reason shall not cause the dissolution of the Company.
