Articles of Incorporation**

ARTICLE I

The corporate name of the club shall be the Vincent High School Athletic Booster Club.

The duration of the corporation is perpetual, unless otherwise stated.

ARTICLE III

The purposes for which the corporation is organized are athletic, charitable, or any other lawful activity for which corporations may be organized under §§ 10-3A-4 et seq., Code of Alabama 1975 as amended, including the following purposes:

The objective of the organization is to provide incremental funds for the athletic programs of Vincent High School. These incremental funds are intended to allow the school to support athletic programs at a level higher than would otherwise be possible without outside financial support.
