

ARTICLES OF ORGANIZATION OF ELECTRONIC MEDIA COMMUNICATIONS, L.L.C.

Pursuant to the Provisions of Act No. 93-724 of the Alabama Legislature, the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I NAME

The name of the Limited Liability Company shall be Electronic Media Communications, L.L.C.

ARTICLE II DURATION

The period of duration is perpetual.

ARTICLE III PURPOSES

The Limited Liability Company has been organized for the following purposes:

Without limitation, to engage in any aspect or facet of (1) selling or marketing advertising for radio or television stations; (2) creating, composing, producing, or directing radio or television programs; (3) purchasing, managing, leasing or operating real or personal property; as well as (4) to conduct any other business for any other lawful purpose allowed under the laws of the State of Alabama.

ARTICLE IV REGISTERED AGENT/OFFICE

The location and street address of the initial registered office shall be 2249 Ridgemont Drive, Birmingham, Alabama 35244 and its registered agent at such address shall be Eduardo Jose Cedeno.
