ARTICLES OF ORGANIZATION AMAZINGKIDS, LLC

Pursuant to the Provisions of Sections 10-12-1, et seq. of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I Name

The name of the limited liability company is AmazingKids, LLC (the "Company").

ARTICLE II Duration

The Company shall have a duration from the date of organization until the fiftieth (50th) anniversary of the filing of the Articles of Organization with the Judge of Probate of Shelby County, Alabama, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III Purposes

The purposes for which the Company is formed are:

- (a) To manage and operate commercial child care facilities; and
- (b) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.
