**FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on December 7, 2004, John C. Oglesby and spouse, Megan H. Jeune, executed a certain mortgage on the property hereinafter described to Option One Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 2004-709520; and

**Lot 6, according to the Survey of Willow Cove, Phase I, as recorded in Map Book 23, Page 75, Shelby County, Alabama records.**






