Regions Bank desires to reconfirm the lien and reconfirm the existence of the \$496000.00 Mortgage as a first priority lien on the Mortgaged Property.


NOW THEREFORE, in consideration of the foregoing, Regions Bank, hereby asserts and affirms the following:
