Know All Men by These Presents: That in consideration of **One hundred ninety six thousand seven hundred fifty eight and no/100 (\$196,758.00)** to the undersigned grantor, a limited liability company, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Donovan Builders, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Rodney Creed Sawyer and Valerie B. Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.


This instrument is executed as required by the Articles or Organization and Operating Agreement and same have not been modified or amended.
