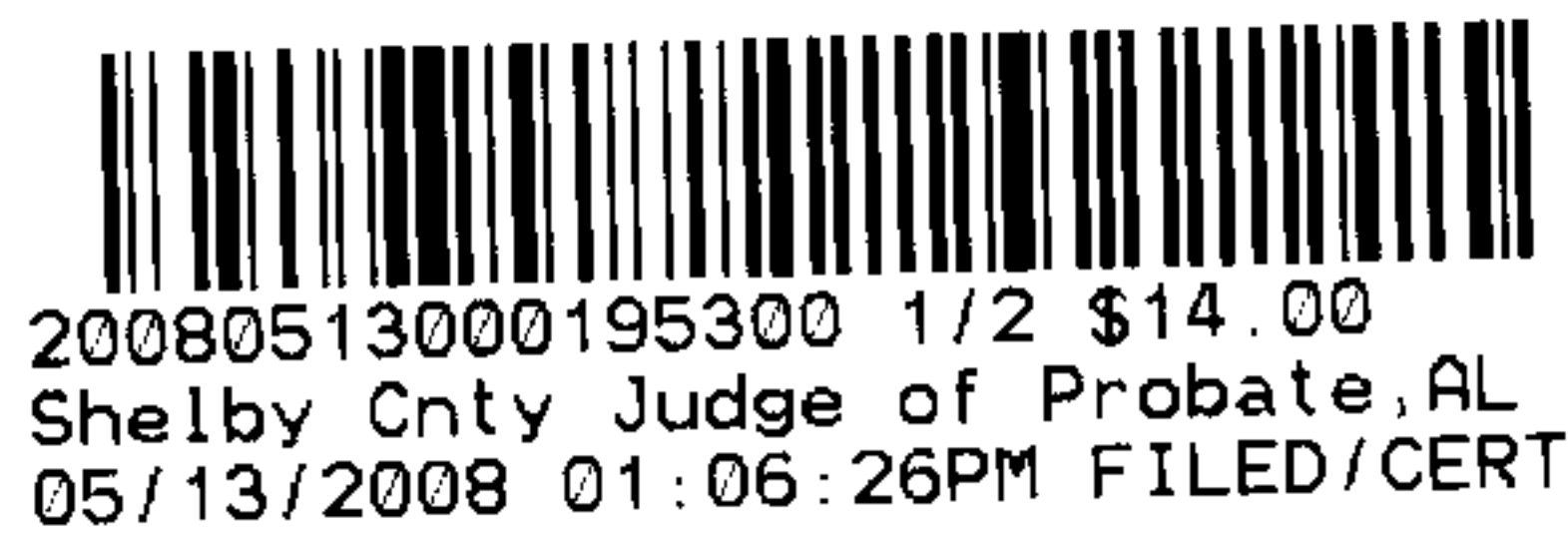

PARTIAL RELEASE
