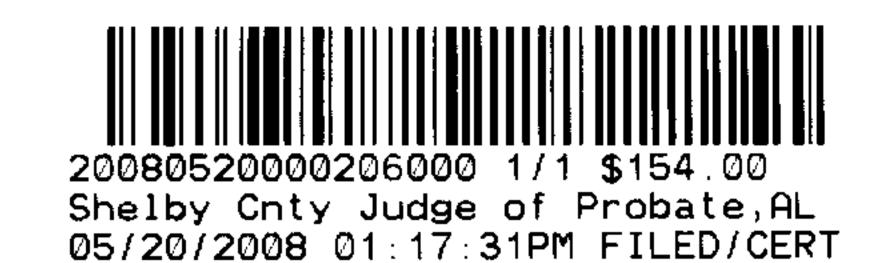
GENERAL WARRANTY DEED
