ARTICLES OF INCORPORATION OF
Oak Mountain Title Company, Inc.

The undersigned, acting as incorporators and desiring to form themselves into a corporation under the Alabama Business Corporation Act, do adopt the following Articles of Incorporation for such corporation:

1. The name of said Corporation shall be:

Oak Mountain Title Company, Inc.

2. The objects and purposes of said corporation shall be to engage in the business of operating a Land Title Company, and any other business which is lawful, allowed and permitted for such corporations under the Alabama Business Corporation Act, and to such end shall have all the powers stated, mentioned, allowed and approved for such corporations by the laws of Alabama under said Alabama Business Corporation Act, which are not prohibited by law to corporations of this kind.

3. The location and principal place of business of said corporation shall be 136 Bowling Lane, Pelham, Alabama 35124.

4. The period of corporation shall be perpetual.

5. The total amount of authorized capital stock shall be \$1,000.00 which shall be divided into 1,000 shares of common stock of \$1.00 par value each. The corporation shall begin business with the subscribed capital stock of \$1,000.00 consisting of 1,000 shares of common stock with the par value of \$1.00 per share all fully subscribed and paid for. The corporation shall be authorized to issue fractional shares.

6. The name and post office address of the officer or agent authorized and designated to receive subscriptions to the capital stock of said corporation is David A. Bedgood, 135 Bowling Lane, Pelham, Alabama 35124.

7. The names and addresses of the incorporators are as follows:

8. The officers and/or directors chosen for the first year are as follows:

David A. Bedgood – President, Treasurer and Director

All shareholders are automatically members of the Board of Directors. All Officers and Directors shall hold office for the period of one year, and until their successors are elected and qualified.

9. All incorporators hereby acknowledge their agreement to a plan for the issuance of capital stock of the Corporation whereby it is agreed by and between the incorporators that all capital stock to be issued pursuant to Section 1244 of the Internal Revenue Code of 1986 as amended, within one year from the date this plan is adopted by the Stockholders and Directors. It is agreed that the effective date of this plan shall be the date on which the same is approved by the Board of Directors.

10. For the purposes of determining the number of holders of record of the stock of the corporation, stock which is held in joint tenancy or common tenancy or by the entireties shall be treated as held by one shareholder. All of the corporation's issued shares of common stock of all classes, exclusive of treasury shares, shall be held of record by not more than thirty persons.

11. The location and mailing address of the corporation's initial registered office is 136 Bowling Lane, Pelham, Alabama 35124, and the name of the corporation's initial

registered agent at such address is David A. Bedgood. The mailing address of the Corporation is 136 Bowling Lane, Pelham, Alabama 35124.



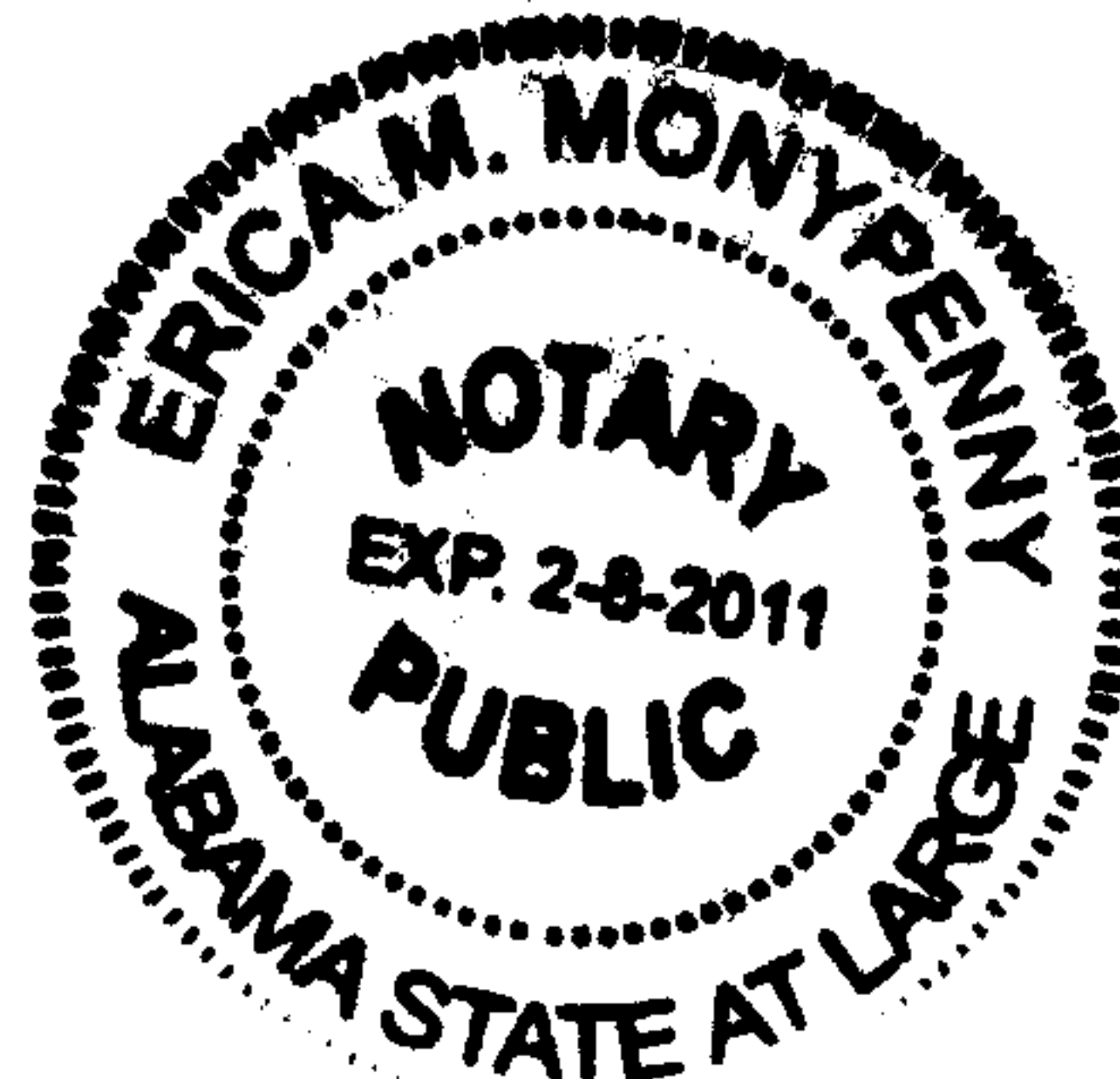
